I do hereby release, acquit, and forever discharge the Walnut Grove High School Band Boosters (WGHS Band Boosters), Walnut Grove High School (WGHS), Walton County Schools, their agents, servants, successors and assigns and all other persons, firms and corporations from any and all actions, causes of action, claims, demand, damages, costs, loss of service, expenses and compensations, which I may acquire or may accrue, arising out of any events taking place on November 12, 2022 or otherwise connected with the 2022 Warrior's Wild Wheel Show. I further agree to agree to hereby indemnify the WGHS Band Boosters, WGHS Band Warrior's Wild Wheel Show, Walnut Grove High School, Walton County Schools, its agents, servants, successors and assigns and all other persons, firms and corporations against any and all claims, demands, damages or causes of action, both legal and equitable, asserted by any third party, their employees, agents, servants, successors and assigns arising from the events taking place November 12, 2022 or otherwise connected with the 2022 Warrior's Wild Wheel Show. This indemnity agreement shall include all reasonable attorneys' fees, costs, and expenses incurred by indemnity. I also understand that I am fully responsible for any Revenue/Sales Tax applicable for items sold at the 2022 WGHS Warrior's Wild Wheel Show.

## Rules and Regulations

The Walnut Grove Band Boosters reserve the right to make final interpretation of all rules. An application is a commitment to show. **NO REFUNDS WILL BE MADE FOR CANCELLATION OR REMOVAL FOR CAUSE. In an event of unforeseen circumstances, the show may be terminated at the discretion of the Director. NO REFUNDS WILL BE MADE FOR BAD WEATHER.**

1. The Application Deadline is November 10, 2022. Received applications that are post marked after this dated will be charged a \$25 late fee if they are approved. Certain categories may already be closed.
2. All exhibitors must sign the release agreement in order for their application to be accepted.
3. Exhibitors may only show and sell work in the category in which they have been accepted. Any items of work not listed on the application, or not accepted, will be removed from the event. We will not take duplicate vendors/exhibitors. We will approve and accept vendors on a first come, first served basis. To be considered the first exhibitor in a multiple product situation you must be the first to submit payment. This means you must submit your fully completed application so that we can approve the application and accept your payment. Walnut Grove Band Boosters reserves the right to deny any application but will consider all applications submitted.
4. Checks returned unpaid by the bank will result in IMMEDIATE DISQUALIFICATION, and a fee of \$35 will be charged.
5. Each booth space is 10 feet by 10 feet. Each exhibitor must keep within the assigned space unless additional space has been purchased.
6. Booths must be neat in appearance and not distract from neighboring displays. Each space must be left clean at the end of the event. We do not provide dumpsters so if you have a large amount of trash you will need to dispose of it properly on your own.
7. All exhibitors will be required to supply their own tents, tables, chairs, ect.
8. Exhibitors may not state tents into the asphalt or concrete on the show grounds. Bring weights to secure your tent. The majority of booths are located on asphalt.
  9. Electricity is NOT provided. If you will be using any type of generator for electricity, you must have prior written approval.
10. No sound equipment such as radios, tape decks, CD players, or stereos are allowed in he exhibit area unless approved by show staff.
11. Pets are not allowed in the show area at any time.

## Rules and Regulations

12. Vehicles are not allowed in the show area once setup time is over, or during the show. All vendors must complete their set up by 9:00am.
13. Booths must be manned at all times, and exhibitors must exhibit their work for the entire show day. Exhibitors may not remove their work until the end of the show day at 2 pm without prior written approval.
14. Exhibitors are not allowed to sell or give away concession food items or drinks without written approval, as we will have specific food vendors at this event.
15. Exhibitors are required to handle their own sales tax.
16. No exhibitor, vendor, visitor, or volunteer or any other persons will be allowed to possess any type of weapons, alcohol, drugs, or similar inappropriate items for any reason. If there is a question as to whether an item is appropriate, please get prior approval from the WGHS Band Boosters before entering into the contract. Inappropriate items include but are not limited to products, symbols, logos, or other items considered to be racist, sexually explicit, or promoting illegal activity or explicit violence.
17. Vehicles will not be allowed onto the show grounds for loading until it is determined the grounds are safe for vehicle traffic. This may take some time and your patience is appreciated. It is best to break down your booth prior to retrieving your vehicle from vendor parking.
18. All vendors/exhibitors must provide their own insurance.
19. Walnut Grove Band Boosters and Walnut Grove High School are not responsible for damaged or stolen property-either real or personal- during or in connection with the event.
20. The Walnut Grove Band Boosters reserve the right to reject any organization whose presentation, goals, or objectives may be offensive or not in the best interests of the community.
21. Any exhibitor failing to meet the requirements and regulations may be asked to leave the show area or will be disqualified.
